## STEP 2: READ INSTRUCTIONS FOR COMPLETING MULTIPLE YEAR LICENSE APPLICATION

The Multiple Year License Application gives license holders the choice to apply for a license that lasts an additional one or two years at the time of issuance or renewal. The fee for multiple year licenses is calculated by taking the annual license fee and multiplying it by the number of years the license will be valid. The instructions for applying for a multiple year license are:

- 1. You MUST submit your 2026 (07/01/2025 06/30/2026) new or renewal license application online at www.gacoam.com before completing this form. NOTE: If you are only applying for the 2026 licensing year, you DO NOT need to submit the Multiple Year License Application.
- 2. If applying for additional years, at least one listed owner must complete the form.
- 3. Download this form and open in Adobe Acrobat Reader. Complete all blue-highlighted sections for your license type and follow Steps 1-7. I

I understand, agree, authorize and consent that GLC may make any and all investigations of my background in order to satisfy the GLC requirements for qualification of the Applicant as a COAM Licensee, which investigations may include, without limitation, criminal history record information, credit history records and reports, tax records, public records and other official records, and the investigation generally of any other matter relating to both me and the applicant being a COAM Licensee. As a potential COAM Licensee or a current COAM Licensee, licensed by the GLC, or as an owner of same, I am required to furnish certain information for use in determining my qualifications. I authorize GLC to share any such information, privileged, confidential, or otherwise, necessary to consider the application to become a COAM Licensee. I further consent to allow GLC to use and share such information in any and all manners consistent with all applicable laws and necessary to effectuate, administer or enforce all rights, orders and obligations arising out of the relationship between the applicant and GLC. A photocopy of this release will be valid as an original thereof, even though said photocopy does not contain an original writing of my signature. This release will expire upon the final termination of the applicant's COAM License obligations to the GLC. I further understand and acknowledge that providing inaccurate or misleading information is grounds for rejection of this application and suspension or cancellation of the COAM License and may subject the applicant and me to the penalties set forth in O.C.G.A. §50-27-87 (d).

## STEP 7: READ INSTRUCTIONS FOR SUBMITTING MULTIPLE YEAR LICENSE PAYMENT

- 1. Remit payment for Multiple Year License Application Fee within three (3) business days from date of uploading your application. Failure to submit payment within this timeframe may result in the denial of your application.
- 2. Payments must be made via ACH(Automated Clearing House) to Truist bank, payable to the Georgia Lottery Corporation. Include your License Number, Business Name and the License Term (2 Year or 3 Year) in the payment reference.
- 3. After making the payment, email a copy of your ACH receipt and your license number to **COAMReporting@galottery.org** with "Multi-Year" in the subject line. This is required to properly credit your payment.
